## AAUW Funds Synergy to Empower Women Louise Brierre

Actions speak louder than words and GRAAUW was outstandingly active this Fall. The 2017 Wine Tasting netted \$4,300. Half of it will go to national AAUW Educational Opportunities Fund. GRAAUW will award scholarships locally with the other half.

I'm new to AAUW, new to the Funds Chair position and new to the newsletter. So please bear with me as I share what I've learned about AAUW, GRAAUW and the FUNDS. As you know "funds" is another word for money, as in "I'm low on funds." This collective noun usually refers to a collection of money and in the case of organizations like AAUW and GRAAUW, or accounting, organizational programming, management, action, taxes and reporting it refers to a particular category or pot of money. The money it takes to "Empower Women" is hard to come by so AAUW focuses on particular aspects of women's lives: Advocacy on public policy; Education (pre-K to post-doc); Campus (make them safe and welcoming); Career and Workplace (doing more for working women); Leadership (widen the pipeline for women); and Economic Justice (work for living without economic barriers). These categories offer AAUW latitude to undertake programs to educate, empower and improve the lives of women and girls. So AAUW set up various "funds" to support targeted programs.

AAUW and GRAAUW are non-profit and tax exempt organizations. To preserve the "tax-deductible" status of contributions and monies raised, AAUW is extremely careful to focus on, identify and separate the activities and programs undertaken as charitable (tax-deductible) under section 501(c)(3) of the IRS tax code. The LEGAL ADVOCACY FUND, the EDUCATIONAL OPPORTUNITIES FUND, the ELEANOR ROOSEVELT FUND, the PUBLIC POLICY FUND, the LEADERSHIP PROGRAMS FUND are each umbrella funds that support research, data analysis, accurate informational reports, grants, networking, workshops, fellowships, tools and skill training, and advocacy on public policies and laws. Contributions by individuals and local branches to all these funds and their individual activities are tax deductible. Having specific pots facilitates budgeting and reporting

of contributions, expenditures and outcomes/ achievements for each fund.

To simplify the paperwork AAUW strongly encourages us, especially as individuals, to direct our gifts to the "grandmother" fund, aka, the AAUW FUND (#9110). Unrestricted gifts to the AAUW FUND allow your money to be used where it is needed most to eradicate persistent challenges and leverage new opportunities. All contributions to the AAUW FUND are used for tax-deductible programs. Only gifts to the AAUW Action Fund may be used for limited voter education, member activism, and Lobby Corps staff support activities. These are undertaken as social welfare activities under section 501(c)(4) of the IRS tax code with contributions that are NOT tax-deductible.

So why are we sending half of our Branch's hard earned money to the AAUW Educational Opportunity Fund? Here's a seriously shortened answer from Nancy Richardson, who has 36 years of experience in the McLean Branch, was twice branch president and was state president in the 1990s:

*"Many members think scholarships and awards from the branch provide more locally visible community outreach, give the branch more control over use of the money earned, more local clout and influence.*

*"What we often don't recognize and build on are the opportunities and influence of the monies sent by all of the branches to national level AAUW. We are branches of AAUW, not independent clubs. We subscribe to AAUW's mission, goals, and efforts to empower women and girls. Without AAUW we'd simply be another gaggle of women, a small group with relatively small clout, and likely a group destined for the dust heap. Through its extensive network, trusted national reputation (especially on Capitol Hill), and multiple diverse efforts to support women and girls, AAUW gives us life, and a highly respected life at that."*

*"Bottom line ... let's continue to support the many talented women and girls who've come before our branches and wowed us with their determination and accomplishments, but let's recognize the true source of our widest reach and greatest success for women, AAUW."*

**November 2nd marked [Latina Equal Pay Day](#)**, the symbolic day when Hispanic and Latina women's earnings “catch up” to non-Hispanic white men's earnings from the previous year. Yes, you read that right—

Latina women have to work until November 2, almost a full extra year, to make up the pay lost to the pay gap over the prior year. That's because Latinas are paid just [54 percent](#) of what non-Hispanic white men are paid.

Join the Richmond Area League of Women Voters for the pre-session legislative roundtable on Wednesday, December 6<sup>th</sup> at 9:00 AM at the *Virginia Credit Union* at 108 N. 8<sup>th</sup> St. to hear firsthand about the pressing issues that will come before state legislators. The day begins with coffee and pastries and then the Pre-Session Women's Round Table (free) until 1:00 pm. Lobby training will be offered after lunch at 2:00 pm.

A full morning of five-minute power speeches from issue experts who have been on the front lines during General Assembly sessions will preview, predict, and prepare us for action in January. They have vastly diverse experiences in monitoring and influencing a wide range of legislation – governance, education, health care, juvenile justice, women's rights, voters' rights, election laws, open government, ethics, safety, environment and conservation, and more. Representatives from the Governor's Cabinet enlighten us on their priorities.

### GENDER EQUALITY - It's Time for Virginia to Ratify the Equal Rights Amendment

GRAAUW has joined the campaign for Virginia's approval of the Equal Rights Amendment. If 38 states approve the Amendment, it could be incorporated into the United States Constitution by operation of Article V, which states that a proposed amendment "shall be valid to all intents and purposes, as part of this Constitution, when ratified by the legislatures of three fourths of the several states."

Alternatively, Congress itself may promulgate the Amendment upon approval by the 38th state.

We are close to that magic number of 38. Just last spring, Nevada became the 36th state to approve the Amendment. The Illinois legislature is debating ratification now. If we pull together, Virginia can be the 37th or even the magical 38th.

The Equal Rights Amendment says: "Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex." As Ruth Bader Ginsburg (now Justice) stated in 1978, the Amendment "does not require similarity in result, parity or proportional representation. It simply prohibits the government from allocating rights, responsibilities or opportunities among individuals solely on the basis of sex."

Contrary to what most Americans believe, women and men do not enjoy equal rights

under our Constitution. It is currently constitutional for laws to discriminate on the basis of sex so long as they merely "further" an "important" governmental interest and are "substantially related" to achieving that interest. If the Equal Rights Amendment becomes part of our Constitution, laws based on sexual classification would be subject to the highest level of judicial review. The government would have to show that its action furthers a *compelling* governmental interest and is *narrowly tailored* to achieve that interest. With its ratification, the Equal Rights Amendment will guarantee equality and serve as a bulwark against government action based on stereotypes, prejudices, or misplaced paternalism.
