### **ERA Amendment Update**

#### Countdown to Ratification of ERA

Beginning on November 9, 2018, the VAratifyERA campaign launched its 10-day statewide tour, logging more than 1,500 miles and over 20 stops from Woodstock to Virginia Beach, from Northern Virginia to Blacksburg. Numerous legislators joined the tour and spoke at colleges and universities along the way. And yes, people did honk to express their love of equality!

GRAAUW luminaries Carol Stephens and Jane Newell spent a day working the tour as the bus navigated the greater Richmond area. When the bus was late from Norfolk State, Trish Wallace enjoyed talking about the ERA with a small crowd of students at VSU. That night a World War II veteran who had worked decades at VSU closed the evening with thrilling words about equality and his support for the ERA.

Next up is the fabulous holiday card campaign. As VAratifyERA says: "Tis the Season to Spread the Word! Give the gift that keeps on giving: Constitutional Equality!" All are encouraged to send their legislators and friends holiday cards signaling the need for ratification of the ERA in 2019. For this purpose, VAratifyERA is distributing 35,000 cards at hubs around the state. GRAAUW's Jane Newell is acting as a distribution hub for the Richmond area. The New Year begins with the General Assembly's 400th session convening on January 9, 2019. VAratifyERA is organizing a welcome-back party to remind legislatures to support ratification. From January 10 through ratification, teams of constituents will meet with their legislators to advocate support for the Equal Rights Amendment. AAUW VA will formally be part of this wave of advocacy with its Lobby Day scheduled for February 7, 2019, at the State Capitol.

### **GRAAUW Wins Mini-Grant**

On November 15, AAUW of Virginia mini-grant selection committee partially granted our branch's application for funds to support distribution of ERA signage to neighborhoods and small businesses in the Greater Richmond area. The grant, which will be supplemented by funds from GRAAUW, will be used to purchase yard signs for members to distribute, personally, to neighbors and small businesses.

GRAAUW's yard sign campaign hopes to generate neighborhood excitement about the ERA and advance the campaign for the Virginia General Assembly to ratify the amendment.

Equally important, the campaign gives us an opportunity to talk with neighbors and business owners about AAUW and its mission. One sign of success will be cultivating new members for GRAAUW. Ultimately, of course, will be ratification of the ERA!

The Public Policy Committee and Board are working out details for purchasing and distributing the signs, which should be available in December.

### Women's Equality Coalition (WEC) Summit December 8

The Women's Equality Coalition is holding the 2018 Women's Equality Summit on December 8, at the Virginia Crossings Hotel, 1000 Virginia Center Parkway, Glen Allen.

This year the WEC is partnering with the Service Employees International Union (SEIU) and has announced it is "focusing on the intersection of the feminist and labor movements." The Summit's topics include healthcare access, economic justice, and democratic participation. The program will also include a joint SEIU-WEC grassroots panel. ## Equity for Women & Girls? ... Some Outside News from the Last Quarter

Outside news stories are not the usual fare for our newsletter, but the following reports bring home why our mission to advance equity for women and girls is so important.

### Secretary of Defense on Women in Combat

On September 25, Secretary of Defense James M. Mattis spoke at VMI. In response to a student's question about women in combat, the Secretary discussed whether including women in combat affected combat effectiveness.

Secretary Mattis said: "[Women in combat] is a very, very tough issue because it goes from some people's perspective of what kind of society do we want ...?

"In the event of trouble, you're sleeping at night in your family home and you're the dad, mom, whatever. And you hear glass break downstairs, who grabs a baseball bat and gets between the kids' door and whoever broke in, and who reaches for the phone to call 911? In other words, it goes to the most almost primitive needs of a society to look out for its most vulnerable.

"This is an issue right now that we have Army, Navy, Marine[s] all looking at as we speak, and that is the close quarters fight being what it is. You know, is it a strength or a weakness to have women in that circumstance?"

Concluding his answer, the Secretary reflected on the environment of combat soldiers: "How did the infantry get its name? Infant soldier. Young soldier. Very young soldier. They're cocky, they're rambunctious, they're necessarily macho and it's the most primitive -- I would say even evil environment. You can't even explain it."

### Federal Judge on Female Genital Mutilation

On November 21, U.S. District Court judge Bernard Friedman ruled that a decades-old federal statute barring female genital mutilation violated the U.S. Constitution. The judge concluded that Congress lacked the authority to enact the statute under the Commerce Clause because "the activity being regulated has absolutely no effect on interstate commerce." The judge did recognize that Congress could legislate in the area of healthcare, but he said that female genital mutilation is "a form of physical assault," not a healthcare service.

The judge rejected the prosecutor's argument that Congress had the authority to act in accordance with a treaty promising protection of children from sex discrimination. The judge said: "As laudable as the prohibition of a particular type of abuse of girls may be, it does not logically further the goal of protecting children on a nondiscriminatory basis."

Trish will discuss the relationship between the aging brain and investment decision-making and explain two rules recently promulgated by the Financial Industry Regulatory Authority (FINRA) to protect senior investors. The goal of the talk is to provoke consideration of our decision-making processes as well as to identity resources that can help us and our families.
