### Public Policy Priorities 2019-2020

This year's public policy priorities for AAUW of Virginia are getting out the vote, passing gender pay gap legislation, and ratifying the Equal Rights Amendment.

### Public Policy Update

Public Policy Chair Trish Wallace helped organize the first annual *Central by Southwest Women's Equality Summit* in Blacksburg, Virginia, on July 20, 2019. Panels included "Faith, Culture, and the Equal Rights Amendment" and "A Better World Because of Equal Rights."

**BOOK:** A Gentleman in Moscow, by Amor Towles. He can't leave his hotel. You won't want to.

In 1922, Count Alexander Rostov is deemed an unrepentant aristocrat by a Bolshevik tribunal, and is sentenced to house arrest in a grand hotel across the street from the Kremlin. Rostov, an indomitable man of erudition and wit, has never worked a day in his life, and must now live in an attic room while some of the most tumultuous decades in Russian history are unfolding outside the hotel's doors. Unexpectedly, his reduced circumstances provide him entry into a much larger world of emotional discovery.

**BOOK:** There There: A Novel, by Tammy Orange. Winner Center for Fiction First Novel prize; one of the Best Books of 2018: The Washington Post, NPR, Time, New York Times, et al.

The story of 12 unforgettable characters, Urban Indians living in Oakland, California, who converge and collide on one fateful day. *There There* is a wondrous and shattering portrait of an America few of us have ever seen.

# Is There a War on Women in the United States?

In its Global Gender Gap Report for 2018, the World Economic Forum ranked the United States 51st of 149 countries, not even in the top third. The United States' score fell below those of our neighbors Canada, ranked 16th, and Mexico, ranked 50th. Especially troubling are the United States' low scores in "Health and Survival," which came in at 71 of 149, and "Political Empowerment" at 98 of 149. The outlook is not great because the United States' rank has been dropping. In 2016, we were ranked 45th of 144 countries; in 2017, 49th of 144 countries; and now we are down to 51st.

Without action by the courts or Congress, dismantling women's rights on a variety of issues can happen and is happening.

Women's access to information, including information that could have life-saving consequences is being removed from government websites. The Department of Health and Human Services (DHHS) has imposed a gag order on Title X (family planning services) providers by prohibitingthem from offering pregnant patients "non-directive counseling" on all legal options relating to pregnancy.

Employers can now deny employees contraceptive coverage on the basis of a religious or moral objection. The new rule also allows universities to deny this coverage to their students. A new DHHS rule allows healthcare providers to deny treatment, services, and information based on personal views. The Department of Homeland Security issued a "public charge rule" that authorizes the deportation of legally present immigrants who access federally funded health, nutrition, or housing programs, however briefly. Undoubtedly, this new rule will have the greatest impact on women and their children.

Equality of rights for women and girls depends on a patchwork of federal and state legislation and court decisions. Legislation can be repealed or, as we saw with the Violence Against Women Act, allowed to expire. Court decisions can be reversed or retreated from. And, as the brief discussion above demonstrates, the Office of the President can undo protections.

Contrary to popular belief, discrimination on the basis of sex is not prohibited by the United States Constitution. The Fourteenth Amendment provides some protection, but not the same protection afforded against racial discrimination or discrimination on the basis of a fundamental right such as the right to free speech.

The only effective means for achieving a durable, textual basis for prohibiting states or the federal government from discriminating on the basis of sex is to add the Equal Rights Amendment to the United States Constitution. The Equal Rights Amendment does not give special rights to anyone; it merely guarantees that the government cannot discriminate on the basis of sex – whether male, female, or non-binary – without violating the Constitution. It states: "Equality of rights under the law shall not be denied or abridged by the United States or any state on account of sex."

Legislation and court decisions are indispensable tools in defending against the war against women in the United States, but none of these tools is as enduring or far-reaching as a constitutional guarantee of equality. Equality of rights under the law – isn't that what the American Revolution was about? At least theoretically?


### Book Talk Tues. Sept. 10th 4:00pm

This is our **ONE** fundraising event to provide local scholarships to deserving young women who have aged out of foster care and to provide support for AAUW National. For GRAAUW to be successful, every member must sell tickets OR buy tickets to make a contribution. The ticket price will remain the same at \$25 each.

The more tickets we can sell, the greater number of scholarships we will be able to award. Last year, we awarded two \$1,000 scholarships and sent \$2,000 to AAUW National.

**NOTE DATE CHANGE**: Due to conflicts with the Richmond Forum on the second Saturday night and the Richmond Symphony on the 3<sup>rd</sup> Saturday night and not being able to find a space for a Friday night, we have selected <u>November 1<sup>st</sup></u>. This means members will need to start selling tickets immediately after the first Branch meeting on September 10<sup>th</sup>. Unfortunately, this date is the Saturday before the election. While I know many of us are doing a variety of things to support our various candidates, I hope we can still have about 8 people who can help set up during the afternoon and that most everyone else will attend the event, bring food, help run the event and clean up.

We will need to know how many tickets were sold to individuals versus contributions made by members no later than October 20<sup>th</sup>. This deadline is necessary so we will know how much wine to order and food to prepare. Tickets will be given to members at the September meeting or mailed to you if you are not in attendance.

In addition to the wine tasting, we will again being doing raffles so each of the interest groups are asked to donate one basket with wine and other items. We will also raffle some of the wines we will be tasting. This has been a good addition to the event to improve our fund raising. We are looking into whether or not we can get an ABC license to sell bottles of wine not opened.

We will need several members to volunteer to help make this a success. So far, Kathy Kelley, Laura Wimmer, Diane Reale, and Jane Newell have volunteered to help. We will need folks to help with preparing food for the event, for set up and clean up, for selling raffle tickets, doing publicity, prepare gift baskets for the raffle and helping with ticket taking the night of the event.
