Mayor Stoney proclaims November 20th Latina Equal Pay Day

Trish Wallace succeeds in getting Richmond to recognize Latina Equal Pay Day. Can you imagine having to work until Nov. 20th of the next year to make exactly what a male makes in one year? Our nation can do better!



At Request of GRAAUW, Latina Equal Pay Day Recognized by RVA Mayor!

At the request of the Greater Richmond branch of AAUW, Richmond Mayor Levar M. Stoney proclaimed November 20, 2019, to be Latina Equal Pay Day. The day symbolized how far into 2019 Latinas must work to earn what men earned during 2018. This year Latinas had to work almost two years to catch up with men, longer than any other ethnic class of women.

GRAAUW Public Policy Chair Trish Wallace explained that it was especially important to recognize Latina Pay Day because it fell so much later in the year than did All Women's Equal Pay Day, which occurred on April 2, 2019. The ratio of Latina women's earnings to white men's earnings (53%) is startlingly less than the female-to-male earnings ratios of Native American (58%), Black or African American (61%), non-Latina white (77%), Native Hawaiian or other Pacific Islander (62%); and Asian women (85%).

The gender pay gap affects not only women but also their families and their communities. Over half of Latina mothers are the key breadwinners for their families according to a 2018 survey by Lake Research Partners and American Viewpoint.

Bills to Watch Out For – Virginia General Assembly 2020

The following table lists by category bills and resolutions that relate to AAUW's mission to advance equity for women and girls. We will update the list periodically.

Category	No.	Description
Education	HB 12	Adds to VA Code: Dep't of Education shall establish procedure for receipt, investigation, and resolution of student complaints alleging discrimination on the basis of sex as prohibited by Title IX.
Health	HB 42	Health care providers; screening of patients for prenatal and postpartum depression; training. Directs the Boards of Medicine and Nursing to adopt regulations requiring licensees who provide primary, maternity, obstetrical, or gynecological health care services to complete a training program on prenatal and postnatal depression in women. Such training program shall include information on risk factors for and signs and symptoms of prenatal and postnatal depression, resources for the treatment and management of prenatal and postnatal depression, and steps the practitioner can take to link patients to such resources. The bill also requires the Board of Medicine to adopt regulations requiring licensees who provide primary, maternity, obstetrical, or gynecological health care services to screen all patients who are pregnant or who have been pregnant within the previous five years for prenatal or postnatal depression or other depression, as appropriate.
	SB 21	Provision of abortion; parental consent requirement; ultrasound requirement; hospital regulations. Removes the requirement that a pregnant minor seeking an abortion obtain either parental consent or judicial authorization. The bill removes the requirement that a pregnant woman seeking to obtain an abortion undergo a fetal transabdominal ultrasound prior to obtaining an abortion at least 24 hours prior to obtaining an abortion, or at least two hours prior to obtaining an abortion if the pregnant woman lives at least 100 miles from the facility where the abortion is to be performed. The bill also removes language classifying facilities that perform five or more first-trimester abortions per month as hospitals for the purpose of complying with regulations establishing minimum standards for hospitals.
